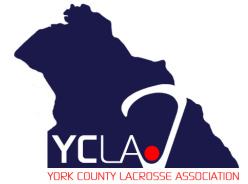

h. Phil brought up that we did not see a good turn out for PCA. Mentioned that it could impact our ability to host a Level 1 coaching clinic next season. Need to understand if there is enough interest and need to request hosting one by June.
